

RESIDENTIAL CUSTOMER PROGRAMS

ENERGY EFFICIENCY

ADVANCED ENERGY REBUILD NAPA PROGRAM [SINGLE-FAMILY]

Provides up to \$17,500 in incentives per home as well as technical assistance to understand the measure's benefits, standards, and program requirements. Measures include: high-performance walls or attics, advanced windows, insulation inspection, high efficiency water heater, heat pumps, ducts in conditioned space, Energy Star appliances, smart thermostats, electric vehicle charging station, induction cooking, heat pump hot water heater, electric heat pump HVAC system, solar panel system with battery storage.

» Serves single-family homeowners in Napa County who lost their homes in the 2017 and 2018 wildfires.

MULTIFAMILY ENERGY SAVINGS PROGRAM [MULTIFAMILY]

No-cost assessment, technical assistance, and rebates for energy saving upgrades.

» Serves multifamily properties with 4+ units or shared mechanical systems throughout MCE's service area*.

LOW INCOME FAMILIES and TENANTS PROGRAM (LIFT) [MULTIFAMILY]

In conjunction with the Multifamily Energy Savings Program, provides an additional incentive of \$1,200 per unit for efficiency upgrades as well as low-cost high efficiency electric heating and cooling appliances.

» Serves income-qualifying multifamily properties with 4+ units or shared mechanical systems throughout MCE's service area*.

GREEN and HEALTHY HOMES INITIATIVE (GHHI) [SINGLE-FAMILY and MULTIFAMILY]

Provides upgrades to improve the health, safety and efficiency of Marin County homes, up to \$2,250 in incentive per unit available, in addition to the Multifamily Energy Savings Program rebates.

» Serves multifamily properties in Marin County participating of the Multifamily Energy Savings Program.

ELECTRIC VEHICLES (EV)

MCEv LOW INCOME EV REBATE [SINGLE-FAMILY and MULTIFAMILY]

Provides up to \$3,500 in rebates to purchase or lease, new or used electric vehicles.

» Serves low-income residents (single-family or multifamily) throughout MCE's service area*.

MCEv CHARGING [MULTIFAMILY]

Provides \$2,500 for electric vehicle charging projects per port, with at least 2 ports.

» Serves multifamily properties throughout MCE's service area*.

ROOFTOP SOLAR

LOW INCOME SOLAR REBATES [SINGLE-FAMILY]

Provides qualified single-family homeowners a \$900 rebate to offset the cost of installation.

» Serves customers who qualify for the Single Family Affordable Solar Home (SASH) program throughout MCE's service area*.

INCOME-QUALIFIED SOLAR REBATE [MULTIFAMILY]

Offers a \$0.41/kW (AC) rebate based on the CEC-AC output rating from the California Solar Initiative Solar Calculator.

» Serves income-qualifying multifamily properties throughout MCE's service area*.

* MCE's service area includes Marin and Napa Counties, and unincorporated Contra Costa County, unincorporated Solano County, Benicia, Concord, Danville, El Cerrito, Lafayette, Martinez, Moraga, Oakley, Pinole, Pittsburg, Richmond, San Pablo, San Ramon, and Walnut Creek.

COMMERCIAL CUSTOMER PROGRAMS

ENERGY EFFICIENCY

COMMERCIAL ENERGY SAVINGS PROGRAM

Offers no-cost energy assessments and start-to-finish project management, in addition to rebates covering between 20–100% of project costs.

» Serves commercial customers throughout MCE's service area*.

AGRICULTURAL and INDUSTRIAL RESOURCES (AIR) PROGRAM

Provides comprehensive, individualized services to agriculture and industrial customers to identify energy efficiency opportunities, develop and evaluate implementation options, and provide incentives in the form of technical assistance, money-back rebates, and financing.

» Serves Agricultural and Industrial customers throughout MCE's service area*.

ELECTRIC VEHICLES (EV)

MCEv CHARGING AT WORKPLACES

Provides \$2,500 for electric vehicle charging projects per port, with at least 2 ports.

» Serves workplaces throughout MCE's service area*.

RENEWABLE PROJECTS

FEED-IN TARIFF (FIT) & FIT PLUS PROGRAMS

Incentivizes the development of local, small-scale renewable energy projects (like solar, wind, or biomass). Previous FIT project locations have included commercial rooftops and parking lots. FIT renewable energy suppliers are not required to be MCE customers.

» Eligible for projects throughout MCE's service area*.

* MCE's service area includes Marin and Napa Counties, and unincorporated Contra Costa County, unincorporated Solano County, Benicia, Concord, Danville, El Cerrito, Lafayette, Martinez, Moraga, Oakley, Pinole, Pittsburg, Richmond, San Pablo, San Ramon, and Walnut Creek.
